WATERWORKS RATE POLICY

The Northern Settlement of Uranium City has a combined water and sewer system. The settlement is not metered and has a flat rate of \$30.00 per month for the water and sewer services.

Several issues plague the settlement's water and sewer system. For the system to be self-sufficient the usage rates would need to be increased to such a high rate that they would be unmanageable by the users. The main issue is that there is a significant water loss within the system itself. This causes the pumps to constantly run to ensure adequate water pressure within the community. Remediation processes are currently in the planning stages with the anticipation that work will begin in the spring of 2023. The settlement's rationale for the setting of a flat fee policy is knowing that the residents would not tolerate the rates that would be required to be self-supportive.

WATERWORKS CAPITAL INVESTMENT STRATEGY

The objective of the capital investment strategy is to work towards waterworks that are as close to self-financing as possible, where users are current with their utility payments for their services. With waterworks infrastructure costs being very high and the Settlement having a small revenue base, total self-reliance is not possible. The settlement anticipates having to transfer supplementary funding from the general revenues of the settlement in order to provide for additional capital costs that will be required to cover the waterworks infrastructure in the future. Due to anticipated future capital replacement, the settlement set up a designated reserve account which has a current balance of \$194,990. In addition, if significant water work upgrades or emergency repairs are required, an application will be made to the Northern Municipal Trust Account for funding from the Northern Water and Sewer Program and the Emergency Water and Sewer Program respectively. In 2015, the Settlement contracted Bullee Consulting Ltd. to complete an Infrastructure Assessment and Upgrades Strategy for the community. The strategy uses the 2020 waterworks system assessment as required by *The Waterworks and Sewage Works Regulations*, 2015 for

infrastructure planning and the 2015 Waterworks System Assessment as required by SaskWater.
